Who Should Apply

We encourage people of every creed, race, gender and philosophy who seek to contribute their skills, knowledge and expertise to the betterment of their community. A Selection Committee reviews applications and interviews candidates.

Candidates Must Have

- ◆ A sincere concern and a desire to help shape the future as trustees in your workplace, families and community and a willingness to commit the time and energy necessary to complete the nine month program
- ◆ Reached 21 years of age
- ◆ No felony or misdemeanor charges or pending orders of protection.

Tuition

\$2,200, paid by sponsor/organization and/or by candidate, 50% deposit due on acceptance into the program. \$200 discount on tuition (\$2,000) if paid in full within two weeks of acceptance. All candidates are responsible for making timely arrangements when sponsored by employer or organization. *Some financial assistance may be extended to qualified individuals who may not otherwise be able to participate. Tuition assistance is awarded based on a statement of need and the amount of funds available. No more than 50% of the tuition will be awarded to any candidate or sponsoring organization and then only in significantly documented cases of hardship. Flexible payment plans can be negotiated as appropriate and prior to attendance. Most charge cards accepted.*

Employer Consent

Employer sponsored applicants who are selected must have employer authorization to participate and to miss work for each of the sessions and retreats.

The Leadership Huntington Foundation has a distinguished history of serving the citizens of Huntington and impacting the Long Island region. Having graduated over 250 graduates, you will find Leadership Huntington's influence in every corner of our community.

In 1995, the Huntington Chamber Foundation together with support from the Huntington Township Chamber of Commerce created *Leadership Huntington* as an annual program to train current and emerging leaders in our community. This exciting new venture fulfilled the joint mission of these organizations, to play an active role as a catalyst to identify, coordinate, and initiate projects with the potential to positively impact the local economy and quality of life in Huntington. In 2007, HTCF changed its name to the Leadership Huntington Foundation and became a fully independent 501(c)3 organization.

Leadership Huntington was created from best practices and professional leadership training materials, as well as from the invaluable experience and talents of more than 50 active volunteer leaders and planners from our extraordinary community. LH has established one of the model community leadership programs in the country right in our own community. As the first and only community leadership program on Long Island, LH joins a distinguished network of more than 1000 community leadership programs in communities across the country.

In addition to the LH Flagship Program, LH has introduced a series of citizen accessible workshops, community tours, and hot topic forums designed to *Develop, Connect, and Engage* a broad range of citizens to actively embrace community trusteeship.

Past projects of the foundation included the initiation and successful implementation of two model child care centers; a primary health care facility – the Dolan Family Health Center - with Huntington Hospital as lead agency for the medically under-served; an eldercare project; and *WorkPlus*, which addressed issues resulting from legislated welfare reform as well as the Huntington Community Council, set up to co-ordinate, and meet the needs of Huntington's not-for-profit organizations.

As a 501(c)3 organization, the Leadership Huntington Foundation is set up to accept tax deductible contributions that help underwrite the programs and activities of the organization. Leadership Huntington is a non-partisan, independent, member supported organization.
